## WHO CAN ENTER

#### ELIGIBILITY

Open to all artists residing in the US. All work must be original and created within the past five years and cannot have been included in a prior SAGE Juried Photography show. Artists may re-submit photos that were not juried into a previous Juried Show at SAGE.

Printed photos cannot exceed 36 inches in width (including any framing). Accepted photos must be exhibit-ready with proper hanging mechanism included (no saw-tooth hangers or clip-on frames will be accepted).

- Non-Refundable Entry fee for SAGE Members:
  - \$15 (For first photo entered)
- Non-Refundable Entry fee for non-Members:
  - \$25 (For first photo entered)
- Each additional piece entered:
  - \$5 per piece
  - (Non-refundable; may submit up to 9 additional photos)

- CaFÉ only accepts JPG or JPEG images that are 5mb or smaller in size. Images must also be at least 1200 pixels on their shortest side.

- Accommodations, including technological assistance and/or assistance preparing and uploading your image are available upon request. We can also walk you through the CaFÉ account setup process.

#### **ACCEPTED PHOTOS**

- Both stages of jurying in this show will be done blindly (the juror will judge solely based on the image of the submitted photo without knowing the identity of the artist).
- Works to be included in the show will be chosen no later than Friday, December 18th.
- If your work is chosen, you will be notified via email.
- All work accepted into the show must be for sale as part of the exhibition.
- For any photo that is sold by an artist who is a Member of SAGE, SAGE will retain a 35% commission of the retail price, and the remaining 65% of the retail price will be remitted to the artist. For any work that is sold by an artist who is not a Member of SAGE, SAGE will retain a 40% commission of the retail price and the remaining 60% of the retail price will be remitted to the artist.
- Do not drop off or ship any work to SAGE until you have been notified of your acceptance into the show.
- You will be required to fill out and return a Loan Agreement Contract once your work has been selected in the show.
- Loan Agreements can be returned via email to sageinfo@sageart.org or included with your accepted photo(s) when they are delivered to SAGE.

- If you are shipping your work, you must include a pre-paid return shipping label (printed with your address and a barcode for the shipping carrier to scan). Unsold work will not be returned without this label.
- SAGE will not accept money orders or postage stamps for return shipping costs on artwork.
- If possible, please do not use packing peanuts to pack your photo. Please submit your work in a sturdy box that can be reused for returning your photo in the event it does not sell.
